Preparing the Building for Public Use

Notes from 3/28/23 Meeting with Rachel Bauman and Andrew Warner

15 members of the congregation (Lisa Pepelea, Earl Barnes, Shirley Barnes, Mary Lukes, Rod Lukes, Dave Pearson, Gretchen Pearson, Liz Bothfield, Jan Helmich, Jean Brown, Carol Murphy, Gary McHone, Steve Pieroni, Rick Stellick, Mary Stellick) and one nonmember (Mary Haag, church secretary) met with Rachel Bauman (our Association Minister) and Andrew Warner (WCUCC Director of Development) to have a conversation regarding expanding the use of our church building to make it a more active and welcoming community resource.

Introductions – Rachel asked everyone to share how they are feeling about Plymouth UCC right now. Some answers were: curious, hopeful, concerned, scared, conflicted, and helpful.

Strengths – endowment, open to change, people of congregation, common goal

Concerns – roof and other needed repairs, energy level of aging congregation, fewer activities, decline in membership

There was some discussion regarding ideas to grow the church. Steve suggested that we should be thinking about Plymouth five or ten years from now – if it's possible that we would no longer be an active congregation, we should start thinking now about what we would like the Plymouth legacy in the community to be.

The following are some thoughts and questions from Andrew and Rachel (not necessarily in chronological order, I tried to group by topic):

Are we wanting to open up the building for financial gain/income or resources to use in maintaining/growing the church or our wider mission?

What would success look like in five to ten years?

How do we use the building to communicate who we are, what can we offer that's different from other churches?

Rachel suggested that we take a good look at the Annual Property Assessment tool that she sent to the Trustees, which considers everything from our mission to our building and property. It can help us come up with a step by step plan for moving forward.

Andrew brought up the WCUCC Foundation, which manages funds for local churches whether or not they are an active congregation. He will send information to the Endowment Committee.

Liz asked Rachel and Steve what other churches have done in similar situation. They gave several examples of churches using their building to provide for a need in their community while contin-

Liz asked Rachel and Steve what other churches have done in similar situation. They gave several examples of churches using their building to provide for a need in their community while continuing to maintain the congregation. Some of these churches used a Catalyst Grant from the Wisconsin Conference.

Ideas were discussed as ways to use the building (both during the meeting and afterward):

Shirley reported that the Trustees have approved a request from Rachel Peller, Director of Wisconsin Partners (a membership-based coalition of statewide associations and community-based civic groups) to use office space in the church three days a week. In exchange for the space (an upstairs classroom) she will barter her services to help plan and organize community events that could be hosted here.

The Trustees have met with Barry Hottman of Iowa County UW Extension regarding unmet community needs, such as co-working office spaces.

Other ideas were a need for quality daycare facilities, a senior center, involvement with the library, space for New Beginnings clothes distribution. None of these activities would limit our ability to operate as a church.

The group came to a consensus that these ideas and others are worth continuing the discussion and this is something that will not be done quickly if we decide we need to repurpose the church building consistent with our mission.

Meeting was called to order by Gary at 7:05. The minutes of the February meeting were reviewed, there were no additions or corrections. Motion to approve the minutes was made by Steve, seconded by Chuck. Minutes were approved.

Committee Reports

Diaconate

- Christina has accepted an associate pastorate with another church and will be cutting her contract here short. Her last service will be on Easter.
- Maundy Thursday confirmed that the soup & sandwich supper will begin at 5:00. Christina will lead the service with Pastor Jim of the UMC.
- Jill will lead the service on 3/26 and Gary will lead on 4/16, and tentatively on 4/23 unless there is a pulpit supply pastor by then.
- The Diaconate, along with representatives from the Barneveld church, are meeting with a pastor on 3/23, who if accepted, would be available for pastor supply through the summer.
- Easter Lily order forms did not go out, Gary will remind the congregation about letting Mary Haag know if ordering, and the cost.
- The Church Profile was completed by the Search Committee and sent to Council members to review. Motion was made by Shirley, seconded by Randy, to accept the Profile as written, with thanks to Lisa, Chuck, and Steve. Motion carried.+

<u>Trustees</u>

- Shirley revised the Budget to reflect changes due to not having a full-time pastor. Use of \$11,000 from the Endowment Fund is anticipated for the year, not including any funds needed for roof repairs.
- Midwest Roofing will be inspecting the roof and attic on 3/23.
- Shirley contacted Rachel Bauman regarding expanding the use of our building and wider mission of our church. Rachel gave Shirley information about two resources, "Annual Asssessment Questions" and a book, Transitioning Older & Historic Sacred Places, which the Trustees are reading. Rachel and Andrew Warner (WCUCC Director of Development) will meet

with the Trustees and anyone else interested in attending on 3/28 to discuss possible processes and resources available from the Conference.

Trustees met today with Barry Hottman from UW-Extension to have him tour the church building and discuss possible uses for the community.

Rachel Peller, Director of Wisconsin Partners (a membership-based coalition of statewide associations and community-based civic groups), has asked to use a room in the church building for her office 3 days/week. Details will be worked out with the Trustees.

Financial

Steve reported that there currently is \$17,900 in the checking account.

Statements were received today, not in a timely manner as requested. Steve will contact Zander Accounting to remind them of agreement.

Pledge cards were sent out. Earl reported that stewardship income is doing better than last year.

Missions

Chuck reported that the church has received thank you notes from all the missions supported in the past year.

The Joyful Noise offering this Sunday will be for the Conference Earthquake Relief fund.

Old Business

Mary and Shirley have not yet met to review the membership list, will do so before next month's meeting.

New Business

Gary asked council members to think about putting a new slogan on the sign in front of church Randy will contact Mary Haag about ordering palm leaves for Palm Sunday.

Mary made a motion to adjourn, Shirley seconded. Meeting adjourned at 8:35.

April 2, 2023

- Steve noted that we should also request an estimate to add flashing around the skylight. That estimate may be added to the current one or as a separate amount.

- Randy moved that we accept the proposed bid with a deadline extension. Steve seconded it, motion carried.
- There will be a congregational meeting on April 16, to be announced on April 9 during the worship service. Gary will ask Mary Haag to send out a mailing about the meeting with a ballot for those who are unable to attend to send in, and to contact Shirley if they have any questions.
